

**Shape Up US Healthiest Family Contest
State by State**

OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN.**
2. **Eligibility**, the **Shape Up US Healthiest Family Contest** is open to each state we hold a Shape Up US Wellness Expo
3. **How To Enter**. The Sweepstakes will begin at 12:00 p.m. (C.S.T.) on January 3, 2011
4. **Internet Entry**: Enter by visiting the Shape Up US Healthiest Family Contest official registration page on the ShapeUpUS.org website (<http://www.ShapeUpUS.org>) and completing all of the required information and following all posted instructions. Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. Complete the entry form and any other required fields and then submit your entry by clicking on the "SEND" button. By entering, you agree to the terms of these Official Rules and to receive e-mails from Sponsor or those directed by Sponsor.
5. Sponsor will not be responsible for incomplete, lost, late, misdirected or illegible entries or for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or Sponsor.
